The Board determined that the amount due is \$40,000.

You must pay to the Board the full amount due of **\$40,000** no later than **April 22, 2024**. Checks should be made payable to the “New York City Election Campaign Finance Fund” and mailed to the attention of Jason Yee, Senior Associate Counsel, New York City Campaign Finance Board, 100 Church Street, 12th Floor, New York, NY 10007, or delivered to the offices of the Board.

If the Board is not in receipt of the full \$40,000 by April 22, 2024, the Independent Spender’s name and the unpaid amount will be posted on the Board’s Website and the Board may initiate a civil action against the Independent Spender and its Authorized Representative to compel payment.

You may challenge this final determination, within four months, in the New York State Supreme Court pursuant to Article 78 of the Civil Practice Law and Rules.
